Children who will have a sibling at the school at the time of entry **and** whose parent(s) are, and have been, regular and committed worshippers in St Mary the Virgin Primrose Hill, St Mark's Regents Park, St Peter's Belsize Park, St Saviour's Eton Road, or St John's Wood Church for not less than two years before the closing date of application. A form of authorisation, signed by the Parish Priest to this effect, is required.
- 5. Children whose parent(s) are, and have been, regular and committed worshippers in St Mary the Virgin Primrose Hill, St Mark's Regents Park, St Peter's Belsize Park, St Saviour's Eton Road, or St John's Wood Church for not less than two years before the closing date of application. A form of authorisation, signed by the Parish Priest to this effect, is required.

In the event that two or more applicants have equal right to a place under the Foundation Place Criteria, the Governing Body will give priority to those children living in nearest proximity to the school. In cases where multiple siblings tie for the last available place, then all will be offered a place, even if this exceeds the planned admission number.
